FD CAEN POWER SUPPLY

Errors appeared on upgrade from SY1527 to SY4527:

- A) Any channel ON were turned OFF without any apparent reason.
 - One LV board cause this conflict at Los Leones:
 - One HV board cause this conflict at Loma Amarilla:
 - The boards affect the new system but not the old one;
- B) After a power cut, random bays couldn't be turned ON.
 - · After resetting several times you can recover all the bays;
 - Firmware problem;
 - CAEN technicians sent an new firmware;
 - In the last 5 months only LL and LA had this issue a couple of times;
- C) Communication problem between CAEN system and Slow Control.
 - This issue cause that CAEN can not be controlled by Slow Control;
 - There is an incompatibility between CAEN system and Slow Control since the last one runs over WinXP while the first one does on Win7 or higher;
 - CAEN's Technicians sent a new OPC server to save this incompatibility but this couldn't solve all the problem;
 - There is a hardware solution in all the FDs that save this incompatibility that delay the CAEN startup to get caught by Slow Control;

Shifters available

- Excellent job done by Bianca Keilhauer on getting remote shifters from different remote stations;
- Mariano (me) is training another local co-worker to conform a 5 persons team "just in case";

Operation (having detectors and shifter premises in account)

- Regular detector maintenance scheduled right after shift on full day tasks in order to minimize travels through police controls;
- Problem investigation postponed until we gain access to travel normally;
- Shifters on shift composed by local team + remote stations. Remember:
 - international flies from September;
 - local travels... the President will decide;
